

Thank you _____ for disclosing details about your relationship with Bjorn Borgen. Per our conversation this morning, I wanted to ensure all the details / facts are in order prior to the hearing in November and capture your statement in writing in the event there is a change to the hearing date or format by Mr. Merrick.

As such, getting your personal verified statement in writing would be ideal. This is simply a statement with a notary public to verify your signature. You may even use this email and follow it with your agreement that the content is accurate and sign and notarize it. Please add or modify what is listed below based on what you recall.

Additionally, this also confirms you provided the photos and letters to be scanned and used for evidence at the hearing and the trial for this case.

Statement of _____

I had an eight year romantic relationship with Bjorn Borgen.

When I met Bjorn Borgen, he did not wear (nor did he ever wear) a wedding ring. I believed he was single. His conversations did not depict nor did he disclose he was married. It was many weeks before I discovered he was in fact a married man. Bjorn Borgen was very assertive and I was led to believe he was estranged from his wife. Bjorn told me they had separate bedrooms and he was rarely at home.

The romantic relationship began during my employment from 1991 to 1996 with Founders Asset Management. Bjorn Borgen hired me to work for his company.

My position with Founders Asset management was Bjorn Borgen's Executive Administrative Assistant.

Mrs. Katherine Borgen was aware of the relationship, and asked Bjorn to stop seeing me. Borgen relayed this to me while he and Mrs. Borgen were away on a trip to Norway together.

Sigrun Tolar, an employee of Bjorn Borgen was fired for notifying Mrs. Borgen of my relationship. Ms. Tolar was caught calling Mrs. Borgen to relay the details of my relationship and was discharged after 15 plus years of employment with Bjorn Borgen. Ms. Tolar was knowledgeable of my relationship with Bjorn Borgen. Bjorn told me that he overheard her speaking to Mrs. Borgen on the telephone and he indicated this was why he fired her.

Ms. Elaine Kostikos, an employee of Founders, to the best of my knowledge, also had an affair with Bjorn Borgen.

One encounter with Ms. Kostikos and Bjorn Borgen happened when I was in the executive suite with Bjorn and Ms. Kostikos called up to see him. Bjorn asked me to hide and he promptly ran after Ms. Kostikos. Another encounter I witnessed Ms. Kostikos and Bjorn Borgen fighting behind closed doors. I inquired why Ms. Kostikos would speak to

him in such a manner. Bjorn replied, "That's just how she talks". In my opinion, this was extremely unprofessional and was a result of their affair.

Dr. Constantine Tsamasfyros was in the presence of myself and Bjorn Borgen and was also aware of my relationship. Dr. Tsamasfyros was engaging in an extramarital affair. At the time he was going through a divorce as the result of his affair.

Mr. Jan Helen, a known associate of Bjorn Borgen was aware of my relationship with Bjorn and participated in extramarital affairs himself by joining both Bjorn Borgen and I at social gatherings with his mistress of eight years, named Ingrid.

I witnessed Mrs. Katherine Borgen waiting in her car in front of my property on more than one occasion looking for her husband Bjorn.

I ended the relationship with Bjorn after eight years. It took three years for the break up. The break up was extremely difficult. I chose to end the relationship because I believed it was morally wrong. Through most of the eight years I thought he was estranged from his wife. It was through conversations I overheard with them that I realized he was in fact not estranged and he was lying to both her and I.

I witnessed Bjorn Borgen lying to Katherine Borgen about his whereabouts via telephone conversations with her when he was with me.

Staff members at Founders Asset Management were aware of my relationship with Bjorn Borgen including Sigrun Tolar.

My sister, [redacted] was aware and a witness to my relationship with Bjorn Borgen. [redacted] my sister, informed me she was sexually harassed by Bjorn Borgen. On one occasion, Bjorn engaged in unwanted sexual contact with my sister at a social event that I, Bjorn and my sister, [redacted] attended with other friends. Bjorn and my sister were dancing together and she said he was touching her and groping her on the dance floor. My sister was married at the time and Bjorn knew of her husband. She relayed the incident to me, however, at the time, I was reluctant to believe her and he denied the incident.

Bjorn Borgen purchased my condo properties as well as a car and most recently paid off the condominium loan this month, October 2010.

Bjorn Borgen wanted me to have a baby during our relationship and in an effort to secure a pregnancy, he accompanied me to a physician's office to determine the viability of becoming pregnant. The conclusion was it was not him, but it was me that was unable to reproduce.

I have in my possession a number of photographs of our vacations together including trips to his island property in Norway, a trip to Las Vegas at the Mirage Hotel for the VIP premiere of Barbara Streisand's performance and other locations. I went out of the country and extended trips about 12 times during our relationship.

I have in my possession a number of photographs with Bjorn Borgen that depict my intimate relationship including photos of Bjorn posing at his property in Norway and other vacations and personal encounters.

I have in my possession letters from Bjorn Borgen that depict his affection for me and capture the relationship as very intimate.

Bjorn Borgen was keeping in touch with me to this day.

During my employment with Founders Asset Management, I took a leave of absence due to the enormous amount of stress and anxiety associated with the affair and the office personnel's knowledge.

My relationship with Bjorn Borgen was a complex and very detailed relationship. We saw each other regularly and my condo, purchased by Bjorn, was situated blocks from his office in Cherry Creek. From this vantage point he was able to visit me daily for lunch and spend afternoons together. Our relationship was not casual. Both Bjorn and I searched for books at the bookstore on "how to tell your children and how to separate from your wife". Bjorn also sought psychiatric counseling associated with the affair and leaving his wife.

Bjorn Borgen would often tell Mrs. Katherine Borgen that he was out of town on business when he was spending time with me in Cherry Creek.

Bjorn Borgen purchased a number of gifts for me over the eight years of our relationship. These gifts included jewelry, a car, two condominiums and original art collections, etc.

Bjorn Borgen purchased one condo for me in 1996 and paid the balance in full October 2010.

I contacted Candy Campbell on October 20, 2010 after Glenn Merrick contacted me and I expressed my concern and fear that Bjorn Borgen may retaliate in response to my giving testimony in this case.

During my discussion with Candy Campbell, I also indicated I could see Bjorn Borgen retaliating when his advances were refused by Candy in public which is the foundation for this legal suit that I am a witness. I told Candy that Bjorn always gets his way. He can afford to pay to get anything he wants. I also expressed my sympathy in this case and that Bjorn, through his attorney would try to discredit my reputation.
